Commission meeting minutes:

Senator Gerald Allen stated that he could not chair the meeting at this time. Emily Thompson will preside over the meeting as commission co-chairman. Commission Co-chair Thompson called the meeting to order at 10:05 a.m.

The oath of office was given to new members, Phillippe Carter and John McCammon. Review of minutes from last commission meeting on March 10, 2011. Motion made to accept minutes. All commission members approved, none opposed.

Representative Williams explained the reference chart that he distributed to the members of the commission. The chart listed names of pending athlete agents and responses made by references. Motion made to amend application to include professional references of non-related persons and

business associates that are not from within the same office. All commission members approved, none opposed. Discussion of creating a PDF electronic application on the SOS website with the notary signature and seal was tabled until further exploration of IT system requirements.

Representative Williams requested information concerning qualifications of athlete agents. Co-chair Thompson explained the qualifications of athlete agents for the state of Alabama as given by Jerry Bassett during a previous meeting. She stated that prior experience is not a requirement for athlete agents in order to encourage compliance with state registration. In order to obtain more information concerning enforcement of athlete agent registration guidelines, commission members discussed inviting a representative from the Attorney General's office to the next athlete agent meeting.


