Commission meeting minutes:

Deputy Secretary Thompson called the meeting to order at 10:08 a.m. and asked the commission members and visitors to sign the attendance roster.

Commission members reviewed the minutes of the commission meeting on February 23, 2012. The minutes were unanimously approved after being properly motioned and seconded.

Deputy Secretary of State Thompson opened the meeting with a discussion about the proposed revisions to the current athlete agent act. Ms. Thompson stated the new bill has progressed through the legislative process with some amendments because of the determination of Representative Jack Williams and Senator Gerald Allen.

Representative Williams continues to report that some applications do not have accurate reference information and made the suggestion that applications with incorrect information be delayed until corrected.

No adverse findings were reported concerning any of the pending athlete agents. All commission members reviewed the new athlete agent applications which are listed below. With the exceptions of Mr. Houston and Mr. Domann, all other new applications were accepted. Motion made to accept all applications except Mr. Domann's and Mr. Houston's made and seconded. No members opposed. Approval of Mr. Domann's and Mr. Houston's applications will be delayed until the next commission meeting for more current or corrected information on the references provided.
