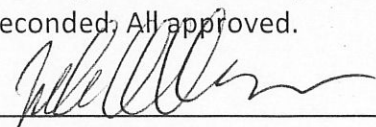
Chairman Williams called for any objections and seeing none called for a motion to approve all new applications as a group. A motion was made and seconded to approve all unanimously. Motion passed.

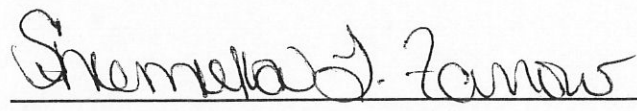
