Chairman Allen and the commission members reviewed the pending athlete agent applications. All were approved with the exception of the application of Raymond Marine. Mr. Marine's application will be decided after receipt of an explanation of his answer to question #11 at the next AAAC Meeting. Attorney for the Office of the Secretary of State, Hope Ayers, will draft a letter to Mr. Marine requesting clarification to question #11.
