Deborah Howard suggested we put on the NVRA 2<sup>nd</sup> Mailer postcard may update voter registration online. Don Milligan discussed the website that people do not realize that they have to complete a full voter registration form for an update on their voter file. John Bennett discussed the changes to the website that will help with the confusion. Adonis Bailey and Jo Stiefel discussed the process on the overwritten names memo they received from the Secretary of State's office. The Board discussed the NVRA 23 form. Don Milligan suggested that the Board of Registrars need limited access to the driver license systems to verify date of births for voter registration. The Board discussed legislative bills and redistricting for the 2018 election cycle. Clay Helms discussed an issue E, S&S system where registrars were saving NVRA Mailing responses without updating information. The system will flag when no response has been entered before saving. No motions were made.
