The information required in this form is required by Title 10A and Title 35.

The undersigned certify that the homeowners' association provided for by declaration and subject to the Alabama Homeowners' Association Act shall be formed by this filing prior to the conveyance of any lot in the development by the declarant in accordance with the requirements of Section 35, Chapter 20.
Unless an attachment to this Certificate of Incorporation provides that a change in the number of directors shall be made only by amendment to the Certificate of Incorporation, a change in the number of directors made by amendment to the bylaws shall be controlling. In all other cases, whenever a provision of the Certificate of Incorporation is inconsistent with a bylaw, the provision of the Certificate of Incorporation shall be controlling.
If a conflict exists between the declaration and the governing documents of a homeowners' association, the declaration prevails, except to the extent that the declaration is inconsistent with the Alabama Homeowners' Association Act.
The filing of the limited liability company is effective immediately on the date filed by the Secretary of State's office or at <b>the delayed filing date</b> (cannot be prior to the filing date of the Secretary of State's office) specified in this filing [10A-1-4.12] If a delayed effective date is not desired do not complete the information in this item.  The undersigned specify / as the delayed effective date (must be on or after the date filed in the office of the Secretary of State, but no later than the 90th day after the date this instrument was signed) and the time of filing to be : AM or PM. (cannot be noon or midnight – 12:00)
