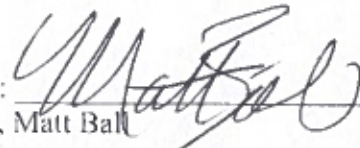
Chairman Ball called for any objections for renewal applicants and seeing none, called for a motion to approve. A motion was made and seconded. MOTION PASSED.

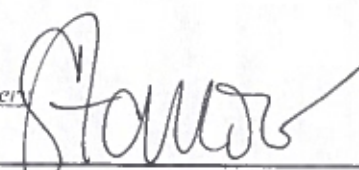
