Treasurer Thomas Neely provided the commission with the financial report.

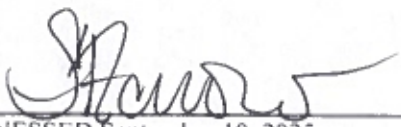
