Deputy General Counsel Meridith Blackburn provided an update on the audit of the Athlete Agent Commission by the Alabama Sunset Committee.

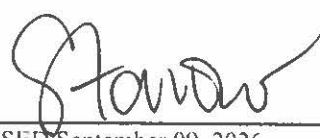
