Based on the following information received today, March 27, 2018:

- The Chilton County Board of Registers admitted that it mistakenly assigned Brendan Gene Beal to House District 49 (Letter attached, signed by all three Registrars),
- The Chilton County Board of Registrars changed Brendan G. Beal to House District 42 today (March 27) following a call from Secretary of State Merrill in the early morning,
- Secretary of State Merrill assured me that the ballot printing company has not begun to print the ballots as of today (March 27) for HD # 42 or HD # 49;

Therefore, Nancy Worley, Chair of the SDEC of Alabama, do hereby amend the amended certification of March 21, 2018, to change the candidacy of SDEC Candidate

to the SDEC House District 42 Male position.



Dear Secretary Merrill and Chairperson Worley:

The Chilton County Board of Registrars mistakenly assigned Brendan Gene Beal (Registrant ID# 674190698) to Alabama House District 49 when he should have been assigned to Alabama House District 42.

Our office received an email from Ed Packard on Sunday, March 25, 2018 notifying us of a mistake our board made in which Brendan Gene Beal was wrongly assigned to Alabama House District 49 when he should have been assigned to Alabama House District 42. Mr. Packard included maps and screenshots to show the mistake.

Clay Helms followed up with a phone call on Monday, March 26, 2018 and Tuesday, March 27, 2018, directing us to review the mistake and correct it immediately.

The Chilton County Board of Registrars has re-assigned Brendan Gene Beal to Alabama House District 42 as of Tuesday, March 27, 2018.


Upon further review, we realized that all voters registered with an address on Eugene Avenue were assigned to the wrong district, fifteen voters in total. We have re-assigned all voters on Eugene Avenue from Alabama House District 49 to Alabama House District 42.


We sincerely apologize to the Secretary of State and the Alabama Democratic Party for this error on our part. We realize the error caused the Alabama Democratic Party to certify a candidate incorrectly based on the voter file in our county, and forced the Alabama Democratic Party and the Secretary of State's Office to re-certify to correct our mistake.
