BALLOT ACCESS

Minor Party/Third Party

Parties that did not receive 20 percent of the vote cast in the last General Election, (17-16-2), Code of Alabama, 1975 often labeled as "Third Parties," must take the following steps in order to obtain statewide ballot access:

- File 150 Copies of the party's emblem with the Secretary of State. (17-8-6)
- Hold a mass meeting, beat meeting or other meeting for the political party to nominate
 candidate (s) for public offices or delegates for a convention at which candidates would be
 nominated. No less than **five days** prior to the date of the meeting, public notice of the
 time and place must be filed with the probate judge in the county where the meeting will be
 held and published in a newspaper of general circulation in the county. (17-16-43).
- File a certificate of nomination of candidates selected at the mass meeting or convention. The chairman and secretary of the mass meeting should file a certificate of nomination for state candidates with the secretary of state. A certificate of nomination for county candidates should be filed with the local probate judge. *The certificate of nomination is due on or before 5:00 p.m., July 1st, six days after the second primary election. (17-7-1) (a) (2). The second primary election is scheduled for June 25, 2002.
- File a petition containing signatures of at least three percent of the qualified electors who cast ballots for the office of governor in the last General Election for state, county, district, or other political subdivision in which the political party seeks to qualify candidates for office. A petition for statewide ballot access must have 39,535 valid signatures. The petition must be filed no later than six days after the second primary, July 1st, with the secretary of state for state or federal ballot access or with the probate judge for county ballot access. (17-8-2.1)
- Minor party candidates are subject to the reporting requirements of the *Alabama Fair Campaign Practices Act* and must also file a *Statement of Economic Interests*, (36-25-15), with the appropriate election official simultaneously with the date he or she becomes a candidate as defined in Section 17-22A-2. For political parties, the appropriate election official is the individual with whom the candidate files his or her qualifying papers. For information on filing the Statement of Economic Interests, call the Alabama Ethics Commission (334) 242-2997.

BALLOT ACCESS

Petition requirements:

- A statement that includes the name of the political party seeking ballot access, the date of the general election for which access is sought, and the name of the political subdivision for which ballot access is sought, if the petition is not for statewide ballot access.
- > Numbered pages.
- Requested information for each person signing includes name, residential address, county of residence, city of residence (if applicable), voting place, date of birth and signature. A signature shall not be deemed invalid for lacking any portion of the requested information if the disclosed information is sufficient for determining the validity of a signature.

Petition suggestions:

- ➤ Have the voter sign in ink and write legibly.
- ➤ Obtain signatures in excess of the required number, as some signatures may not be valid and/or identifiable.
- ➤ Keep a copy of the petition.

PETITION FILING LOCATIONS

State and federal petitions should be filed in the Elections Division of the Office of the Secretary of State, located in the State Capitol, Room E-204, Dexter Avenue in Montgomery, Alabama.

Petitions for **county ballot access** should be filed in the office of the **county probate judge.**
