

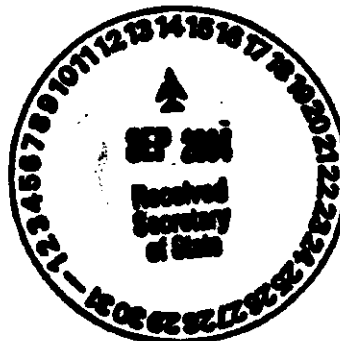
Dear Secretary Worley,

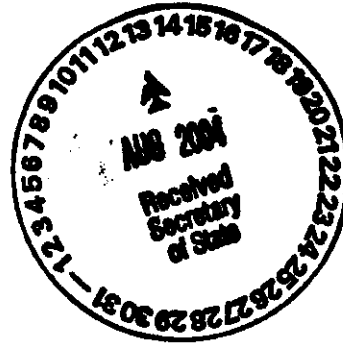

### CERTIFICATION AMENDMENT

Pursuant to Section 17-16-36 (d), Code of Alabama, 1975, and according to Rule 820-2-4.09 (2)(a), concerning amendments to ballot certification, I hereby certify that Ginette A. Dow has been disqualified as the Democratic nominee for District Court Judge, 10<sup>th</sup> Judicial Circuit, Place 10 for the general election to be held November 2, 2004. Please do not include the name of Ginette A. Dow as the Democratic nominee in the Secretary of State's certification of candidates to the Probate Judges.

As a result of Ginette A. Dow's disqualification, and according to Section 17-16-41, Code of Alabama, 1975, regarding the filling of vacancies in nominations, the state executive committee may "...fill such vacancy, either by action of the committee itself or by such other method as such committee may see fit to pursue."
