(Proposed by Act No. 2013-269)		<b>PROPOSED STATEWIDE AMENDMENT NUMBER FIVE (5)</b>  Proposing an amendment to the Constitution of Alabama of 1901, to amend Amendment 597, now appearing as Section 36.02 of the Official Recompilation of the Constitution of Alabama of 1901, as amended, to clarify that the people have the right to hunt, fish, and harvest wildlife subject to reasonable regulations that promote conservation and management of fish and wildlife and preserve the future of hunting and fishing. (Proposed by Act No. 2014-286)
